#### SEC MANAGED FILE TRANSFER (MFT) PLATFORM **MODERNIZATION**

**Problem** 

The SEC required a secure, scalable platform to replace their outdated file transfer system, which could not handle large data volumes and posed security risks. A new solution was needed to manage internal and external file transfers, improve efficiency, and strengthen data security across a hybrid cloud

Solution

Infotrend implemented IBM Aspera on AWS, leveraging DevSecOps principles and automated workflows to streamline file transfers. The solution included real-time malware scanning, encryption, and secure cloud infrastructure. Infotrend also managed operations and maintenance (O&M), ensuring high availability and compliance with **FISMA** and **NIST 800-53** standards.

Results

Infotrend's solution improved file transfer speeds by 30%, enhanced security, and reduced overall operational costs by using scalable AWS cloud resources. This modernization directly aligns with SEC's need for secure and cost-effective cloud solutions to manage large volumes of mission-critical data.



#### FDA CDER ELECTRONIC SUBMISSIONS PROGRAM (ESP)

Problem

The FDA required a modern, scalable platform to handle over 200 TB of electronic submissions (eCTDs), ensure compliance with FDA's stringent regulatory requirements, and provide real-time processing and reporting capabilities for drug evaluation.

Solution

Infotrend developed the Automated Submission Receipt (ASR) system, integrating it with FDA's databases and supporting the migration to the LORENZ docuBridge platform. This solution included continuous support, DevSecOps practices, and enhanced workflows to meet FDA's security and compliance requirements while processing large volumes of eCTDs.

Results

Infotrend's system processed submissions with 99% accuracy and reduced errors during the migration. The platform's high availability and compliance capabilities resonate with FDA's objective of streamlining cloud-based application management and ensuring data integrity across its mission areas.



#### FEDERAL AGENCY EDISCOVERY (ED3) CLOUD PLATFORM

**Problem** 

An undisclosed federal agency needed a secure, cloud-based system to manage over 1 PB of litigation data, replacing their on-premises infrastructure. The existing system was costly and unable to scale with increasing data needs.

Solution

Infotrend migrated the agency's eDiscovery system to Casepoint, a FedRAMP-certified cloud platform, improving the system's scalability, performance, and security. Infotrend implemented advanced search and analytics capabilities to support investigations and ensure 24/7 availability of critical legal data.

Results

Data processing times were reduced by 40%, and the system's scalability significantly improved while cutting operational costs. This cloud migration experience directly supports the agency's goals of improving data management, security, and reducing costs via cloud-based operations.
