

We are implementing a cloud-based electronic Discovery 3.0 (eD3) system, transitioning the agency from Recommind to Casepoint. We deployed and secured a new FedRAMP-compliant eDiscovery platform tailored to the specific needs of the different Offices, providing customized user interfaces for access control and document production. Our work involves creating complex document productions based on meticulous searches and review team tagging. We train review teams on effective search strategies, redaction techniques, extracting information from large data sets, and reviewing and suggesting improvements to existing processes.

National Science Foundation (NSF) Office of Inspector General (OIG) Freedom of Information Act (FOIA) Infotrend supports NSF OIG providing expert, experienced FOIA analysis and litigation document management services.
